NYSGA Golf Cart Request Form



The NYSGA takes seriously its responsibilities under the American with Disabilities Act ("ADA") to provide reasonable accommodations to tournament spectators possessing an ADA covered disability. Generally, the NYSGA does not allow tournament spectators either to have use of a golf cart or to share a golf cart with a player during an event. However, in collaboration with the host golf course sponsoring an NYSGA tournament, pursuant to this Policy, the NYSGA is willing to accommodate spectators with an ADA disability by allowing them to ride in his/her own golf carts, while observing an NYSGA tournament. (Spectators with a covered disability would still not be allowed to ride in a player's cart).

Generally, an ADA covered disability is defined as a "physical or mental impairment that substantially limits one or more of the major life activities of the individual". See, 42 USCA §12102. Spectators with a "temporary" injury or impairment that are not an ADA disability would not be allowed use of a golf cart under this Policy.

In order to allow the NYSGA to evaluate a request for a claimed disabled spectator to have use of a golf cart, as well as to enable the host golf course to make the necessary advanced preparations, spectators seeking to have use of a golf cart must timely complete the accompanying "Disabled Spectator Golf Cart Request Form".
