# New York State Golf Foundation 2020 Grant Application

The New York State Golf Foundation 501(c)(3) is the charitable arm of the New York State Golf Association. The primary focus of the Foundation is providing scholarships to employees of NYSGA member clubs and junior golfers, but grants are also awarded to organizations promoting the game of golf. These funds can help with startup costs, subsidize fees for families who face financial need, and elevate the program experience for participants.

# Eligibility

- Applications must be submitted by an authorized representative of the golf facility or organization hosting the youth golf program.
- Future funding eligibility is dependent on the success in implementing programs and require submission of performance metrics and spending/budget data.
- The NYSGF reserves the right to conduct in-person evaluations of program implementation and may request the opportunity to promote other golfing opportunities to students.

### Funding

- The program must begin within six (6) months of receiving the grant or funds must be repaid in full.
- The NYSGF may elect to grant a lesser amount than requested.
- Payment is made directly to the club, foundation or organization affiliated with the program (501c3 status required).
- The organization must submit a Form W-9: Request for Taxpayer Identification Number and Certification along with this application.

## **Evaluation Criteria**

- Impact: Evidence that the program will have a significant impact and outcome benefitting the participants.
- Participation Experience: Evidence of an effective program structure, sufficient length of program, opportunities for participants to progress, and plans to expand the program after the first year of funding.
- Population Served: Special consideration may be given to programs in economically challenged regions of New York.
- Leadership: Commitment of the PGA/LPGA Professional or other authorized representative and support of the golf club management to making the program a success for the participants.
- Performance During Previous Grant Periods: The extent to which an applicant has implemented programming, achieved desired outcomes and complied with grant policies during any previous grant periods.

### **Review Process**

- The NYSGA Foundation will acknowledge receipt of application within ten (10) business days.
- After the committee has reviewed the application, the applicant will be notified of a decision in writing.
